

# IADC Drilling HSE Europe 2005 set for 19-20 May

**IADC DRILLING HSE** Europe 2005 Conference & Exhibition is scheduled for 19-20 May in Esbjerg, Denmark, at the Esbjerg Performing Arts Centre. This conference promises to leave the participant with the latest in the industry's HSE initiatives and issues, from risk management, improving safety behavior and culture to reducing environmental impact of drilling operations. The conference begins with registration from 7:30-8:30 am followed by remarks by IADC President **Dr Lee Hunt**, **Peter Helmer Steen**, Deputy Director General, **Danish Energy Authority**, and **Esbjerg Mayor Johnny Søtrup**. A keynote address follows from 9-9:30.

Session I, Safety Work Place Risk Management, begins at 9:30 with three presentations. Session Chairmen are **Gert-Jan Windhorst**, **Noble Drilling**, and **Andrea Forzan** with **Saipem**. The first presentation, by **Steve Cross** with **ENSCO International**, examines *PARC It! The Management of Change*. **Anthony Stammers**, **UK Health and Safety Executive**, next presents *Risk Management in the Work Place: A UK Health and Safety Executive Program of Work to Reduce Accidents in Drilling and Deck Operations*. **Steve L Davis** with **Shell** presents *Establishing and Implementing Effective Stop Work Authority Programs*.

Session II is a panel session that begins at 11:30 am and focuses on *Proactive Cooperation in Getting to Zero: What is Missing?* Session Chairmen **Harald Bratthammar** with **Smedvig** and **Magne Ognedal** with the **Petroleum Safety Authority Norway**, will moderate a panel session that will present evidence that regional cooperation between and among all stakeholders is essential in reducing accidents.

Session III begins at 2:00 pm with *The Human Factor Influence on Behavior and Culture*, moderated by session Chairmen **Soren Prissholm**, **Maersk Oil & Gas**, and **Knud Sjørup Nielsen**, **Maersk Contractors**. The first presentation is *Reducing Incident Risk: Using Human Factors to Influence Behavior* by **Liz Cullen**, **Atkins Consultants**. **Hilde Heber**, **Petroleum Safety**

Authority Norway, will next present *Human Factors in the Drilling Area: How Can Authorities Follow Up to Reduce Serious Incidents?* **Anne Vegge** with **Dolphin Drilling**, present *Actions Taken to Improve the HSE Culture in Dolphin and Measuring the Effects*.

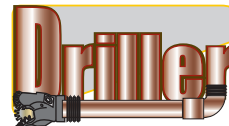
Session IV, moderated by session Chairmen **John Karish**, **ENSCO**
