IADC Antitrust Policy and Guidelines and committee Mission Statement

John Pertgen reviewed the IADC Antitrust Policy and Guidelines and the Chairman covered the Mission Statement with the attendees.

Review of action items: There were no outstanding action items.

Regulatory Review:

John Pertgen provided a brief overview of the following issues being tracked by IADC:

USCG - Harmonization of Lifesaving Equipment with international standards

- Inland navigation rules now in the CFR
- Salvage and Firefighting vessel response plans for tankers
- No more time and one-half sea service granted for 12 hour watches on MODUs
- NI DPO proposed baseline requirements (per Nautical Insitute)
- DOI Bureau of Energy Management, Regulation, and Enforcement (BOEMRE) final SEMS rule
- OSHA Safety standards for cranes and derricks
- DOT Drug testing (concentration amount sent to MRO from laboratories on positive samples)

FMCSA-Commercial Driver License changes (State to state reporting of violations)

- EPA -Mandatory Greenhouse Gas Reporting
 - -Vessels PCB free if sold international or for scrap (MOU with MARAD)
- IMO Anti-fouling convention
 - -Wider Caribbean Region has no garbage discharge zone (includes GoM)

Main Presentations:

- 1. Advanced Rig Technology report on Downtime Statistics Program- Robert Urbanowski (Precision Drilling).
- 2. Lubrication Condition Monitoring: The Complete Picture- Peter Pilon (Kittiwake Americas) [Presentation was followed up with a practical demonstration of the equipment and system usage.]

Afternoon Portion:

2011 Chairman Election was held: Mr. Ken Gardner was re-elected as Chairman of this committee for 2011.

The Chairman stressed the importance of getting involved in the regulatory process as the revisions and new regulations are being developed....rather than merely reacting to the new regulations and not giving enough constructive input at the front end to assist in the finalized revisions.

Open Forum:

The members discussed topics for future meetings and presentations, which included:

- -Education of all personnel to understanding what their data is displaying and the overall consequences of equipment failures?
- -Physical activity of personnel (i.e., drillers, who may be chair-seated for the entire shift)
- -Practical examples of using data input to assist personnel in making informed decisions
- -Alarm management (for consistency)
- -How to process information overload
- -Interoperability of hardware systems
- -Short lifespan of new electronic systems

The Chairman suggested that out committee invite other IADC committee chairman to our meetings so they can provide updates from their group.

One member queried the group about anyone's use of remote monitoring of the data that companies are collecting centrally.
