

IADC HSE ENVIRONMETAL SUB-COMMITTEE MEETING 17 April 2013

Agenda Item #1: Welcome, Introductions & Building Information

The IADC HSE Environmental Sub-Committee was called to order by Sub-Committee chair, Jennifer May Guidry. Jennifer welcomed everyone and thanked them for attending. Joe Hurt, IADC, provided attendees with building and emergency response information. Ms. Guidry then asked everyone to introduce themselves, see the attached attendance sheet.

Joe Hurt, IADC, reviewed the IADC Anti-trust Policy & Guidelines, calling attention to prohibited discussion topics. For a copy of the IADC Anti-trust Policy & Guidelines refer to http://iadc.org/antitrust/.

Agenda Item #2: Environmental Regulatory Briefing

Joe Hurt, IADC, informed the group he had contacted a Region VI Representative to discuss the NOI, E-NOI issues via WebEx connection. The EPA representative informed him that they are not able to respond on a number of issues until they receive an official decision from Washington.

Jennifer May Guidry, Hercules Drilling, updated the group about the meeting between Stone Energy and the EPA regarding new lifetboat permit issues. It was decided that Stone Energy will assemble an information packet for the EPA to read and take to Washington so that they are better able to make an educated decision regarding regulations.

John Pertgen, IADC, provided the Committee with information on two IADC-published semi-annual reports:

- International Standards Activities affecting the Offshore Oil and Gas Industries
 - This report provides a handy reference to the standards development activities of various organizations (e.g., the International Maritime Organization, International Labor Organization, the International Organization for Standardization, and various international trade associations).
- Federal Regulatory Actions Impacting the Offshore Industry
 - This report provides a reference summary that reflects the regulatory actions, announced in the Federal register by U.S. governmental agencies, which may affect operations in the oil and gas industries.

Additionally Mr. Pertgen provided a brief overview of the following key issues that have been modified since our last committee meeting:

- MARPOL Annex 5
 - o Prohibits discharge of vessels unless authorized
- Clean Air Act
 - Follow best management practices for now
- Vessel General Permit
 - o Was 26, but is now 27

o IADC will be forming a group to update Vessel General Permit Guidelines detailing what is required and what IADC recommends to meet these requirements

Agenda Item #3: General Discussion of Environmental Issues and Best Practices

Tina Lapene, Rowan Companies, informed the group that she is a committee member of the GMG 29000 Mud and Produced Water Characterization Study. The EPA is re-evaluating discharge requirements and has created this group to design a study to collect samples. A consulting company has recently been brought on board to help with the research.

Joe Hurt, IADC, informed the group that IADC has sent a letter to the Illinois legislature raising issues of concern regarding the proposed amendment to H. B. 2615, House Amendment No. 3 that would require a union licensed water well driller on each drilling crew.

Members discussed the Center for Sustainable Shale Development which offers accreditation based on a 15 point check. More information can be found at <u>Center for Sustainable Shale web page</u>. The 15 requirements can be found <u>Performance Standards -3-27-GPX.pdf</u>.

Members discussed issues they are having with the new Fuel Sulfur Standards. Companies are now writing the requirements into their contracts.

Agenda Item #5: Equipment Environmental Rating

Representatives from National Oilwell Varco (NOV), Trey Mebane, David Justiniano, and Jake Flittner, gave a presentation on the Environmental Performance Metric score card their company is creating. The purpose of the score card is to help standardize manufactures requirements, improve environmental performance, and allow the public to have a better understanding of safety precautions taken in the drilling industry. The score card is based on manufacturing process and operation length.

Currently, manufactures are deciding what to measure and how points are to be defined and are seeking input form drilling contractors on the following points:

- What are companies' policies regarding equipment training?
- Are companies wanting to "go green" with equipment? Will this make its way into bid specs?

- How long will companies keep paying to have a piece of equipment fixed before purchasing a new one?
- What do drillers actually want to measure? Will it benefit someone? What are the implications?

Some recommendations the meeting attendees made were:

- Make the equipment fool proof. The less employees have the handle equipment, the less chance
 of an accident
- Are the metrics consistent with all vendors?
- How does this point system reflect that your company is meeting standards?
- Is this based on looking at the entire rig? Prioritize by criticality?
- May want to discuss with the Maintenance Committee
