#### Agenda Item #1: Welcome, Introductions & Building Information

#### Agenda Item #3: Subcommittee Reports

#### Environmental Subcommittee

Jennifer May, Hercules Offshore, Inc. reported:

- The HSE Committee's Environment Sub-Committee is reworking the Environmental Reporting Guidelines to bring them more in line with the EPAP guidelines. If any attendees want a copy of these guidelines contact Joe Hurt. The attendees were instructed to send suggestions for changes to Joe Hurt joe.hurt@iadc.org.
- At the last meeting the attendees voted to recommend to the EPAP Operating Committee
  that there should only be one IADC committee providing guidelines on environmental
  reporting. They also voted to recommend that the working group should be under the
  HSE Committee through the Environmental Affairs Sub-Committee. The attendees voted
  to review the OGP and API, OGP, IPIECA guidelines for environmental reporting and see
  if they are acceptable substitute for current EPAP or HSE Committee Reporting
  Guidelines.
- The next Environmental Sub-Committee will be held on 14 December 2011 at IADC office. Suggestions for discussion topics should be submitted to Joe Hurt at <a href="mailto:joe.hurt@iadc.org">joe.hurt@iadc.org</a>.
- Joe Hurt reported on the EPAP Operational Committee meeting that was recently held in Amsterdam. Joe reported that the EPAP meeting attendees agreed with the HSE Environmental Sub-Committee's recommendation of having only one IADC group to develop environmental tracking guidelines. They also agreed that it should be under the HSE Committee.
- The EPAP Operational Committee also agreed to review the OGP and API, OGP, IPECA combined guidelines on environmental reporting and provide comments to <a href="mailto:anne.otton@iadc.org">anne.otton@iadc.org</a> or <a href="mailto:joe.hurt@iadc.org">joe.hurt@iadc.org</a>.

## Incident Statistics Program (ISP) Subcommittee

Joe Hurt, IADC reported changes to the ISP Guidelines and FAQ. The new guidelines will be distributed to participating companies in January 2012.

## Agenda Item #4: Julia Swindle, IADC - SEMS

- Reminded the group that SEMS I goes in-effect on 15 November 2011.
- Utilized a presentation to report on upcoming SEMS II.
  - Guidelines for SEMS II have been released and comment period closes 14 November 2011. Ms. Swindle encouraged the attendees to review the guidelines and provide IADC comments as well as comment to the docket.
- Informed the group that there is a SEMS Toolkit available for download and use on the IADC website.

## Agenda Item #5: Regulatory Report - John Pertgen and Joe Hurt, IADC

John Pertgen, IADC, provided the Committee with information on two IADC-published semiannual reports:

- International Standards Activities affecting the Offshore Oil and Gas Industries Posted in April and October.
  - This report provides a handy reference to the standards development activities of various organizations (e.g., the International Maritime Organization, International Labor Organization, the International Organization for Standardization, and various international trade associations).
- Federal Regulatory Actions Impacting the Offshore Industry Posted in January and July
  - This report provides a reference summary that reflects the regulatory actions, announced in the Federal Register by U.S. governmental agencies, which may affect operations in the oil and gas industries.

The most recent version of the Federal Regulatory Actions Impacting the Offshore Industry was posted on 6 July 2011. A few of the items highlighted by Mr. Pertgen are listed below (for a complete list, please see the full report at link above):

- Department of Homeland Security
  - The deadline for States to implement new minimum standards for Driver's Licenses and Identification Cards has been extended to 15 January 2013.
- US Coast Guard
  - Lifesaving Equipment: Protection Testing and Harmonization with International Standards- the USCG issued a Notice of Proposed Rulemaking which proposes to amend its regulations for certain lifesaving equipment, including launching appliances, release mechanisms and survival craft, among others. This proposed rulemaking would also harmonize the Coast Guard's design, construction, and performance standards for lifesaving equipment with international standards.
  - O Amendment to Marine Safety Manual, Volume III USCG issued a Notice of Proposed Policy Change with regard their cancelling the issuance of AB-MOU credentials. If the policy is cancelled, a mariner holding a credential endorsed as AB-MOU would, upon renewal, have the endorsement converted to AB-Limited, or, if the individual is so qualified, to AB-Any Waters, Unlimited.
  - Merchant Mariner Medical Advisory Committee (MMMAC) this is a newly formed committee which held its inaugural meeting in September 2011. The Committee's purpose is to advise the Secretary on matters related to medical certification determinations for issuance of merchant mariner credentials; medical standards and guidelines for the physical qualifications of operators of commercial vessels; medical examiner education; and medical research.

- Department of Interior / BOEM
  - Reorganization of Title 30: BOEMRE splits to become BOEM and BSEE the DOI issued a Direct Final Rule outlining the authorities of the two new agencies.

  - Revisions to Safety and Environmental Management Systems (SEMS)
    Requirements BOEMRE issued a Proposed Rule with updates to the original
    SEMS regulations, including the addition of 4 new elements. [Please see
    Agenda Item 4 below for more information].
- Department of Interior / BSEE
  - NTL: Temporary Helideck Closures BSEE issued a Notice to Leaseholders offering guidance on the recommended safety practices for temporary helideck closures.
- Department of Labor / Occupational Safety and Health Administration (OSHA)
  - Occupational Injury and Illness Recording and Reporting Requirements OSHA issued an extension to the comment period for their proposed rule to update its Injury and Illness Recording and Reporting regulation. This rulemaking will replace the current Standard industrial Classification (SIC) system list of industries with those based on the North American Industry Classification System (NAICS) and add additional reporting requirements for employers.
  - OSHA recently issued a letter of interpretation stating that: OSHA Recordkeeping (OSHA 300) requirements apply to the following offshore environments.
    - US Inland Waters
    - State territorial seas which is 3 nautical miles from the coastline except for 9 nautical miles for the Gulf Coast of Florida, Texas, and Puerto.
    - Outer Continental Shelf (OCS) for structures permanently affixed to the bottom on OCS lands.
