- 1. Derek Morrow opened the EGM with a short status update on the South East Asia Chapter. The Chapter remains a registered entity with the Registrar of Societies, Singapore however, there has been little activity in recent years and the previously elected office bearers are no longer in the region. The rules and bylaws of the Chapter are current and will be observed in the conduct of the EGM. These rules require a quorum of at least 7 member companies, and present today are representatives from 11 members.
- 2. The purpose of holding an EGM is to act on the desire of both IADC Corporate and the member companies located in South East Asia to revitalise the dormant SEA Chapter, commencing with the election of office bearers to replace the current officials who are no longer in the region.

- 3. The financial status of the Chapter has been verified at a meeting held yesterday between M DuBose, D Morrow and Mr. John Thong, Partner Thong & Lim Chartered Accountants, as follows:
 - The Chapter accounts have been finalised, audited, and lodged through 30 September 2011
 - The Chapter accounts for 30 September 2012 have been prepared and audited awaiting signature by Chapter office bearers prior to lodgment.
 - HSBC Bank has closed the Chapter account due to the prolonged period of inactivity. The proceeds of the account totaling SGD88030.82 have been issued by bank cheque which is being held by Mr Thong pending instructions from the Chapter. It is noted that this cheque has 6 months validity, expiring 6 May 2014. After this time the funds will be held in trust by HSBC and may be difficult to recover.
 - Thong & Lim have a number of unpaid invoices for accounting services to the Chapter going back over 12 months.
- 4. Following a letter issued by email to member companies in SEA by C Hlaing, a number of member representatives were put forward to represent their respective company on a new Chapter advisory committee. From those nominees, candidates came forward for the vacant Chapter officer positions of Chairman, 2x Vice Chairmen, Secretary / Treasurer, as follows:
 - Chairman Mr Glenn Gipson of Diamond Offshore
 - Vice Chairman Mr Manav Kumar of Dynamic Offshore Drilling
 - Secretary / Treasurer Mr Graham Buchan of Halliburton
- A formal vote to elect each of the above positions was taken by show of hands. All three candidates were elected unanimously. The IADC staff and the Chapter members present congratulated Messrs. Gipson, Kumar and Buchan on their election.
- 6. A further candidate for the second Vice Chairman position will be pursued by the incoming committee and officials.
