800-815	Welcome, Facility Orientation & Introductions Eamonn Young – Chairman, opened the meeting with a facility safety orientation, then everyone gave introductions. IADC Anti-Trust Guidelines Rhett Winter – IADC, reviewed the IADC anti-trust guidelines.
815-915	Open Discussion: Safety Issues, Regulatory Notices & KSA's Eamonn Young, Most of the open discussion revolved around the following topics: -electronic logs, and are drivers familiar with them? Are they able to manipulate them? Are they better or worse...do they cause issues? -There's also a big disconnect between the company man on locations and rig move companies, this has big strain on efficiency. Equipment, therefore, doesn't show up in a timely manner. -There was also talk on a South LA. Parish that is bad for weighing and permitting oilfield loads. Different regions pose different problems. -The committee also addressed night moves and whether they are safe or not. The push for doing night moves seems to be cooling off, but they are still done on infield moves. There's much debate on whether or not they can be done safely. There were questions on if there's any data to justify savings or spending on 24 hour moves. The committee agree to form a subcommittee to meet the day before the next meeting to address night moves. A possible one page recommendation from IADC on whether they're good or bad is the idea. Additionally, the KSA for rig movers will also be revisited. Once a concensus is agreed on night moves, this recommendation will then be presented to the north American onshore advisory panel.
