#### Call to Order:

# IADC Members Only discussion, Closed Session, (Information Sharing):

- Various members requested an action item to reach out to Konsberg and invite them to the next meeting to discuss issues with thrusters.
- NOV cyclone dust collector piping issues, internal piping configurations allow for inadvertent "sandblasting" in a concentrated area of the vessel, which could lead to premature wear. Recommend internal inspections to verify the piping configuration.
- Mattco style pulsation dampeners, recommend inspecting the lower plate cap screw when
  possible, as there have been some recent failures with these cap screws. These screws are only
  accessible when the unit is removed from service.
- Member wanted to discuss pipe handler dies falling out and was curious if other member where having the same issue.
- Top drive service loops, power cables twisting internally.
