# WellSharp Live Notice WSL-21-01: WellSharp Live Update & Updated Schedule of Fees

### **Changes to WellSharp Live Guidelines**

The following WellSharp Live (WSL) guidelines will be effective May 1st:

- WSL Test Codes must be purchased prior to scheduling a virtual course. Please reference the updated Schedule of Fees attached.
- Training Provider's will be able to deliver WSL using their preferred virtual platform, the virtual platform must meet the attached minimum requirements.
- Final exam roster must be submitted to <a href="mailto:krewsupport@endeavortech.com">krewsupport@endeavortech.com</a> no later than 72 hours before the exam date (no exceptions).
- ProctorU will be providing the proctor service for the virtual WSL courses. Lloyds Register will continue to proctor in-person WellSharp courses.

## **NEW - Proctor Service Information for WellSharp Live exams**

ProctorU is an online proctoring platform that enables students and professionals to take exams from their home. Replicated after the physical testing center, ProctorU monitors examinees using remote screen-sharing technology and webcams. ProctorU offers the following features which will enhance our exam proctoring process:

- One-on-One proctor to student ratio
- Live proctor throughout entire exam for authentication, room pan, computer security check and real time monitoring of eye and head movement
- Enhanced Authentication process: photo ID, facial recognition, and biometrics
- Al Platform that locks the trainees web browser, monitors lighting changes, and irregular activity

#### **NEW - WellSharp Live Test Code Information**

WSL test codes will be needed to schedule and deliver virtual courses. While the test code price has increased, each test code includes proctoring and unique enhanced features for Training Providers and students.

## **Unused WellSharp Test Code Conversion**

Accredited providers can do a 1-time conversion of any unused test codes, to the new WellSharp Live test codes. Since the cost per test code is less than the cost of the new WellSharp Live test code, the dollar amount spent on the test codes will convert to the number of test codes.
