Summary of Occupational Incidents Introductory Briefing

GENERAL UPDATE

In 2022 a workgroup was formed under the IADC HSE Committee to completely review and rewrite the IADC ISP Guidelines document. In the past, updates were made annually but this was the first complete rewrite in more than a decade. The new document is now evergreen and is online at the ISP site to ensure that all participants and HSE professionals are referring to the most recent version. The Q&A document was reviewed, and many answers were incorporated directly into the guidelines thus eliminating additional documents and potential for contradictions. A question-and-answer link was also added to the ISP site so that participants may still submit questions that will be reviewed and answered by the HSE committee.

Lastly, in late 2022 the IADC Executive Committee approved a proposal to build a modern, internet-based ISP system allowing much more participant insight and direct access to reports. Two workgroups were formed and met to scope the project and development began on 12 January 2023. This new ISP system was launched in the fall of 2023.

Data gathered in the IADC Incident Statistics Program (ISP) data base, shows that the oil and gas well drilling industry continues work toward reducing incidents on rigs. Despite increased rig demand in 2024, the incidence rates decreased slightly from 2023. Although IADC ISP calculates both Incidence rates and Frequency rates, this

report is based on Incidence rates which are calculated on incidents per 200,000 man-hours.

The Summary of Occupational Incidents (SOI) is compiled annually from data volunteered by drilling contractors worldwide to the IADC ISP Program. During 2024, 76 contractors participated in the ISP representing a total of 418,375,348 million man-hours worked. Contractors striving for safety improvement by participating in the ISP program reported 956 Recordable incidents, 271 Lost Time incidents including 8 fatalities.


REGIONAL REPORTING

Safety data is compiled separately for Land and Offshore operations for nine geographic regions. This report is not designed to measure region against region, but to provide companies operating within each region tools to measure their efforts and make improvement in their safety efforts year over year.

INDUSTRY IMPROVEMENT

2024 saw the drilling industry's worldwide Lost Time Incidence Rate decrease to 0.13 from the 2023 reported rate of 0.14. The 2024 Recordable Incident rate decreased to 0.46 from the 2023 reported rate of 0.51. The oil and gas well drilling industry's efforts towards safety have resulted in the industry's occupational LTI Incidence rate to improve from more than 14.00 in 1963 to 0.13 in 2024, which is a 99% improvement.

Fatalities



FATALITIES

In 2024 the industry's fatalities decreased to 8 incidents compared to 10 incidents reported in 2023. According to the data reported in 2024, four (4) fatalities occurred to employees who had more than ten years of service with the company. Two (2) more fatalities occurred to employees who had betwen five and ten years of service. Two (2) fatalities occurred during rig/equipment repairs or maintenance. Three (3) of the fatalities occurred to floormen.


Regional Summaries: Man-Hours vs Fatalities


European Land and Offshore categories together worked 25.3 million man-hours in 2024 with zero (0) fatalities. European offshore accounted for 21.2 million man-hours with zero (0) fatalities while European Land had 4.2 million man-hours and zero (0) fatalities. US Land and Offshore contractors together worked more than 60.6 million man-hours with two (2) fatalities. US Land had 44.9 million man-hours with two (2) fatalities while US water had 15.7 million man-hours and zero (0) fatalities. Canadian contractors accounted for 9.6 million man-hours and zero (0) fatalities. Canadian Land had 8.9 million man-hours and zero (0) fatalities while offshore had 720,761 man-hours and no fatalities. Central America and Caribbean accounted for 4.8 million man-hours with one (1) fatality. Land operations reported 537,817 man-hours and no fatalities while water operations reported just over 4.3 million man-hours and one (1) fatality. Africa combined land and offshore accounted for 56 million man-hours with zero (0) fatalities. Africa Land accounted for 41.3 million man-hours with zero (0)

fatalities while Africa Water had 14.8 million man-hours and no fatalities. The Middle East region accounted for 192.7 million man-hours with four (4) fatalities. The Land division had 120.4 million man-hours and three (3) fatalities while there were 72.3 million man-hours and one (1) fatality for the offshore division. Asia Pacific accounted for 29.7 million man-hours and no fatalities. Water had 24.2 million man-hours and no fatalities while the Land Division had 5.5 million man-hours with no fatalities. South America made up 33.4 million man-hours with one (1) fatality. Land had 9.5 million man-hours and one (1) fatality while Water had 23.9 million man-hours and no fatalities. Australasia made up 6.2 million manhours with no fatalities. Land had 3.1 million man-hours with no fatalities while offshore had 3.1 million manhours with no fatalities.

Lost Time and Recordable Incidents by Region


Lost time incidents among US Land workers decreased from 0.44 in 2023 to 0.32 in 2024. The Total Recordable Incidence Rate improved from 1.53 in 2023 to 1.26 in 2024. US Offshore LTI Incidence rate remained 0.11 in 2024 and Recordable Incidence Rate improved from 0.70 in 2023 to 0.56 in 2024. European Land workers saw their LTI rate worsen from 0.33 for 2023 to 0.96 for 2024. The Recordable Incidence Rate worsened from 0.52 in 2023 to 1.20 in 2024. European Offshore workers LTI rate worsen from 0.12 for 2023 to 0.19 for 2024 while the Recordable Incidence rate worsened from 0.41 in 2023 to 0.67 in 2024. Canada Land LTI rate remained 0.27 for 2024, while their Recordable Incidence rate of 0.88 in 2023 rose to 1.40 for 2024. Canada Offshore





workers saw their LTI rate remain at 0.00 for 2024. The Recordable Incidence rate of 0.00 for 2023 rose to 0.28 for 2024. Central America and Caribbean Land LTI rate remained at 0.00 for 2024. Their 2023 Recordable Incidence rate of 0.93 dropped to 0.37 for 2024. Central America and Caribbean Water 2023 LTI Rate of 0.21 worsened to 0.24 in 2024. The Recordable rate of 0.49 for 2023 also worsened to 0.66 for 2024. Africa Land

LTI rate decreased from 0.36 in 2023 to 0.27 in 2024. The Recordable Incidence rate decreased from 1.22 in 2023 to 0.87 in 2024. Africa Water LTI rate increased from 0.04 in 2023 to 0.09 in 2024 and their Recordable Incidence rate increased from 0.12 in 2023 to 0.24 in 2024. Middle East Land LTI rate remained at 0.05 in 2024. Their 2023 Recordable Incidence rate of 0.16 improved to 0.12 in 2024. Middle East Water LTI rate



remained at 0.04 in 2024 and their Recordable Incidence rate increased from 0.15 in 2023 to 0.17 in 2024. Asia Pacific Land LTI rate increased from 0.00 in 2023 to 0.04 in 2024, and their Recordable Incidence rate increased from 0.11 in 2023 to 0.18 in 2024. Asia Pacific Water 2023 LTI rate of 0.05 increased to 0.07 for 2024 and their Recordable Incidence rate improved from 0.22 in 2023 to 0.20 in 2024. In 2023, South America Land had an LTI rate of 0.04 which worsened to 0.13 in 2024 and a 2023 Recordable rate of 0.25 which worsened to 0.59 in 2024. South America Water 2023 LTI rate was 0.07 which worsened to 0.10 in 2024 and a 2023 Recordable rate of 0.27 that worsened to 0.28 in 2024. Australasia Land had a 2023 LTI rate of 0.63 which improved to 0.39 for 2024 and Recordable incident rate of 1.06 for 2023 which worsened to 1.37 for 2024. Australasia Water had a 2023 LTI rate of 0.32 which improved to 0.00 for 2024 and a 2023 Recordable incident rate of 1.38 which improved to 0.77 for 2024.

Greatest Risks

Incidents occur in many places around the rig and to all crewmembers. Many types of equipment and rig operations are involved in incidents and all parts of the body are at risk. Incident data are analyzed by occupation, body part, incident type, equipment type, operation, location time in service and time of day the incident occurred.

Data from the IADC ISP show that of all the categories, as with previous years, the Floorman position incurred the largest percentage of Lost Time and Recordable injuries.

Fingers remained the most vulnerable part of the body.

Caught Between and Struck By accounted for the most Lost Time Injuries and Total Recordable injuries.

Pipes/Collars/Tubulars/Casing is the equipment responsible for the most Lost Time and Recordable incidents.

Tripping In/Out and Rigging Up/Down accounted for the most Lost Time and Recordable incidents.

The most Lost Time and Recordable injuries in drilling operations occurred on the rig floor.

Lost Time and Recordable injuries based on Time in Service were led by employees with between one to five years of service.

The Most LTI and Recordable incidents occurred at 11:00 hours.

November accounted for the most Lost Time and Recordable incidents.

The 26 – 35 year age range accounted for the most Lost Time and Recordable incidents.

Conclusion

Activity in most sectors of the industry increased in 2024. Overall, Lost Time incidents rates and Recordable incident rates decreased slightly in 2024 as compared to 2023, despite an overall uptick in rig activity.






Total Industry LTI & Recordable Incidence Rates vs Man-hours (Figure 1)






Total Industry Lost Time Incidents by Month (Chart 1)


Total Industry Recordable Incidents by Month (Chart 2)





Total Industry Lost Time Incidents by Occupation (Chart 3)




Total Industry Recordable Incidents by Occupation (Chart 4)


Total Industry Lost Time Incidents by Body Part (Chart 5)


Total Industry Recordable Incidents by Body Part (Chart 6)





Total Industry Lost Time Incidents by Incident Type (Chart 7)




Total Industry Recordable Incidents by Incident Type (Chart 8)


Total Industry Lost Time Incidents by Equipment (Chart 9)


Total Industry Recordable Incidents by Equipment (Chart 10)





Total Industry Lost Time Incidents by Operation (Chart 11)




Total Industry Recordable Incidents by Operation (Chart 12)


Total Industry Lost Time Incidents by Location (Chart 13)


Total Industry Recordable Incidents by Location (Chart 14)





Total Industry Lost Time Incidents by Time in Service (Chart 15)




Total Industry Recordable Incidents by Time in Service (Chart 16)


Total Industry Lost Time Incidents by Time of Day (Chart 17)

Total Industry Recordable Incidents by Time of Day (Chart 18)






Total Industry Lost Time Incidents by Age (Chart 19)



Africa Total LTI & Recordable Incidence Rates vs Man-hours (Figure 4)





Asia Pacific Total LTI & Recordable Incidence Rates vs Man-hours (Figure 5)





Australasia Total LTI & Recordable Incidence Rates vs Man-hours (Figure 6)





Canada Total LTI & Recordable Incidence Rates vs Man-hours (Figure 7)





Central America & Caribbean Total LTI & Recordable Incidence Rates vs Man-hours (Figure 8)





European Total LTI & Recordable Incidence Rates vs Man-hours (Figure 9)





Middle East Total LTI & Recordable Incidence Rates vs Man-hours (Figure 10)




