# 2025 Q2 IADC UBO&MPD Committee Meeting. June 10-12, 2025 Transocean, Houston TX

#### **Meeting Minutes**

## 2025-06-10 - Day 1 (Tuesday)

Oscar Gabon opened the meeting

- Introduction, thanked Transocean for hosting and sponsoring the meetings, assigned note taker
- IADC Antitrust Guidelines, Transocean safety brief, Safety Moment (Distracted Driving during Summer Break, Heat related illnesses)

## Updates on development of API Equipment, R&M standard based on the gap analysis performed by the working group (Gabby)

- There is a need for an API standard for MPD using existing documents (16 series docs) but goal is to have a more detailed document
- Meeting on the 18<sup>th</sup> for the CSOM to formally approve submitted form
- Submitted API 16MPD with comments to amend the riser. Anyone who wants to be in meeting should get a hold of Gabby to be added by Jose. Meetings are every Monday at 08:00 hrs
- Vanni mentioned they will also plan on defining what an MPD riser joint is in API 16F
- Will have breakout session after due to high interests in topics
- Gabby will follow up with Jose to confirm date if on 18<sup>th</sup> or 19th

#### API Document Updates (API 79-2, 79-3, 92M):

- API 79-2 (Ahmed Shimi)
  - Sent for ballot, received 104 comments. Going over technical and editorial comments. Should finish by the end of week and send out
  - Will need a small room for breakout
- API 79-3 (Andre Fernandes)
  - Received comments after 2nd ballot, reviewed 25%, 150 more comments.
  - Will update and send back.
- API 92M Re-Write (Adam Keith)
  - Working on MPD Operations Matrix example
  - Discussed potential MPC section but no work started yet
  - Will review during next quarterly meeting and send to API for ballot

#### IOGP Well Control Incident Classification Update (Oscar):

- Have been meeting with IOGP regularly, meetings have been productive.
- IOGP asked IADC to review document for input.

#### ISO MPD Standardization Update:

- CNPC, pushing for ISO standard for MPD with concerns that API is not robust enough
- An ISO MPD standard was started by CNPC and we were hoping to oversee the work.
- They showed us the outline but refused to show the actual document.
- It's been officially is announced that the MPD plan has been officially launched on the ISO platform for voting
- The MPD standard was submitted for voting on May 16, 2025 with voting ending on July 10, 2025.
- Each country has only has one representative, whom is allowed to cast a vote for that country.
- This MPD standard proposal can be overturned if majority votes rule to do so
- We can participate as individuals but there is only one representative from each country, with ANSI being the representative for USA for ISO.
- Overall goals for us: avoid any IP that requires the use of any specific vendor, pipe, supplier, etc.
- Rolland has to vote for USA, but if more countries (Canada, Brazil, Norway, etc.) can participate to vote "no", this can help slow the MPD Standard submission
- Gabriela's Gap Analysis work is also needed for this, with CNPC's limited experience on land and jackup/platform rigs.
- Oscar will send ISO link out for meeting minutes.

#### BSEE Updates (John Thain):

- NTL document from BSSE only allows the reduction of hydrostatic pressure or MW used by the anticipated friction pressure expected, based on hydraulic modeling
- o This may affect MPD operations (such as for DPPTs) because of this.
- Meeting on Thursday, during regular OSC meeting. During the first half of the meeting,
   BSEE will be there to discuss and answer any questions regarding the NTL.
- BSEE will allow up to 5 questions to be asked per company.
- Jim Rocco wants to get a group together during the comments period with BSEE, to ask as many questions as possible. We want to ask questions to keep the topic of discussion open with BSEE to understand why this NTL was released, e.g. "what is the reasoning for this" and not "why we shouldn't state this")
- o Transocean and Noble will be present.
- Involvement is encouraged if anyone else wants to join.

- Concerns with revision/review/approval process for IADC, how training providers are evaluated. We've addressed personnel but concerned about the technical reviewers and process.
