Agenda Item: Welcome and Opening Statements:

John Karish, Director SHE, EnSCO International and HSE Committee Chairman opened the meeting. He then turned the meeting over to J P Mook, NOV to give the building orientation and safety instructions.

John explained the agenda and asked everyone to introduce themselves-see the attached attendance sheet.

Joe Hurt reviewed the IADC Antitrust guidelines.

Agenda Item: General Discussion of Results of EDN Exercise Working Toward Zero.

John Karish summarized the results of the workshops conducted at the July meeting.

Agenda Item: Regulatory Issues

Alan Spackman gave a report on a number of offshore regulatory issues.

1. IMO MODU Code: 2009 Code scheduled for adoption by the Assembly in Nov/Dec 2009. Draft is available on IADC website.
2. STCW training for mariners. John Pertgen, Assistant Director/Offshore Technical and Regulatory Affairs is heading up IADC's task group to develop draft of a revised Assembly resolution A.891 (21) on Training of Personnel on Mobile Offshore Units. Anyone wanting to assist on this effort should contact John.
3. Maritime Labor Convention 2006 – See available PowerPoint presentation
4. USCG ballast water management systems. IADC developing response to proposed rule. Major difference from IMO requirements is the amount of pathogens allowed in water discharged. As proposed, MODUs (and other vessels) only need Phase II systems if ballast is to be discharged within twelve miles of the shoreline, but proposal is somewhat ambiguous. If USCG requires Phase II systems this may prove problematic since no systems are currently available that will meet Phase II requirements, and discharges meeting phase II requirements may violate the EPA's Vessel General Permit.
5. COFR Insurance Requirements have been lowered.
6. Jones Act modification has been delayed.

Joe Hurt gave a report on a number of land regulatory issues.

1. OSHA PPE Consensus Standard final rule was issued to upgrade the references to current standards referred to in OSHA PPE regulations.
2. OSHA issued a proposed rule - HAZCOM Harmonization with UN guidelines. This proposed rule is an effort to bring US HAZCOM in line with international standards.
3. SPCC Regulations – Joe commented on citations being issued by the EPA.
4. OSHA Fire Resistant Clothing citations.
5. Lifting related incidents. MMS cross industry Lifting Data Committee was established to study lifting related incidents and provide information to lifting safety on the OCS.
6. Joe discussed OSHA's concern with gin-pole trucks. The IADC Rig Moving Committee has completed the Oilfield Gin-Pole Truck guidelines. They will be presented to the IADC Executive committee then when approved will be posted on the IADC web page for free download.

Agenda Item: Swine Flu

Agenda Item: Life Boat Issue:

Mike Parrish, ENSCO made a presentation on life boat safety issues. He discussed guidelines from flag states as well as IMO. After Mike's presentation the group discussed the need for good work instructions and adequate training of the Coxswain. Another issue is the need for a clear line of command for lifeboats. No matter who a person is, the Coxswain is in charge. One attendee commented that during hurricane Katrina the reason the USCG operated so efficiently while other governmental agencies floundered was because the USCG has established a strong chain of command. There was also discussion on the release gear not being manufactured by the lifeboat manufacturer which in some cases can cause ergonomic problems for the lifeboat attendants to re-attach the boat after launching it.

Agenda Item: IADC Incidents Statistics Program:

Joe Hurt briefly discussed the changes that the ISP Task group recommended for 2010 guidelines. After discussion on the recommended changes, Larry Hill made a motion to accept the changes. Farrell Moughon seconded the motion. A short discussion followed and the changes were approved by the drilling contractors represented.

At the end of the discussion and vote on the ISP changes there was time left so Joe introduced Dusty Stasyszen of Goober Drilling to discuss their experience with the new IADC RigPass to Go program.
