Agenda Item: Welcome and Introductions

Justin Hodges, Committee Chairman opened the meeting and introduced Jerry Rials, **Moore Truck & Equipment** meeting host. Joe Hurt gave a safety briefing and explanation of the building facilities. Justin then asked the attendees to introduce themselves, see the attendance list. Justin thanked Jerry and Moore Truck & Equipment for hosting the meeting.

Agenda Item: General Discussion – Safety Minute – Best Practices

Discussion items:

1. There was discussion regarding the use of a third party to conduct “Sonic Testing” or non destructive testing of equipment.
2. An incident where there was a misuse of a high pressure test pump to clean equipment that resulted in a failure of connections and a fatality.
3. One attendee discussed their use of natural gas/diesel combination fuel to operate their trucks.
4. One state is stressing the use of bio-fuel in trucks and new tier diesel engines.
5. A mud pump fell off of a lowboy. The workers were trying to get the job done and did not wait for proper equipment to properly load and secure the mud pump.
6. There was discussion regarding tickets being issued in one part of the US now being shared with other regions.
7. One attendee discussed a problem they had a driver applicant who lied on his application and failed a CDL drug test.
8. One company has been using “Auto Scan” system which also helps the drivers keep up with hours of service (HOS).
9. Companies obtaining heavy load permits need to include the trailer serial number on the permit.
10. In some states the counties / parishes are adding their own weights and measures divisions.
11. One attendee commented that companies need to inspect frac tanks before leaving locations. The lights and other safety equipment must meet the same standards as trailers. Some drivers have received citations when they move frac company rental tanks.
12. There was discussion of two derricks being moved and the trailers turned over. One derrick was destroyed while the other was field repairable.

Agenda Item: Truck Braking Systems:

Presentation on truck braking systems by Derek Tabur, Selecttransportation Resources LLC discussed the changes in requirements for new truck braking system.

Agenda Item: Load Sensing Device

Jeff Hankins, All Wheel Drive Equipment discussed their load sensing device. After his presentation, there was discussion of load pin sensor options.

Agenda Item: Discussion on Process to Determine Gin-Pole Truck Work Load Limits, Safety Factors, Load Charts

Justin Hodges and Michael, McDowell, Aiken Engineering discussed the process that Hodges trucking went through to certify some of their trucks. They demonstrated the charts (tables) that were used to list the specifications of the truck. Copies of the charts (tables) are to be posted on the Rig Moving Committee documents web page.

David Watkins is to provide a drawing of stinger truck to be used for use in certifying stinger type trucks.

Action and Next Meeting Agenda Items

The next meeting will be hosted by Kennedy Wire Rope on 8 September 2010. The items are to be addressed prior to or at the next meeting.

The committee decided that the goal of the next meeting is to develop a training syllabus for Gin-Pole Truck Swamper. Items to be provided prior to the meeting and presentations for the meeting are:

2. Each company is going to send copies of their programs to Joe Hurt prior to the meeting so that Joe can combine similar items into one document.
3. The companies are to provide Joe Hurt information on ensuring competency of: Drivers, Swampers, and Riggers.
