

**IADC Rig Moving Committee**

**Agenda Item: Welcome and Introductions**

- Anthony Zacniewski, Committee Chairman opened the meeting and thanked Wilbanks Trucking, Inc for hosting the meeting and providing lunch. The hotel safety briefing and other information regarding the hotel was given by a member of the hotel's staff. Anthony then asked the attendees to introduce themselves (see the attendance list).

**Agenda Item: General Discussion – Safety Minute – Best Practices**

- Anthony Zacniewski – Opened the floor for general discussion, safety alerts & best practices. Some of the issues discussed were:
  - A member shared an incident where the welds broke on the support frames of a truck mounted crane while picking up drill pipe in the Middle East. The crane portion fell off of the truck with the operator in the seat; however, there were no injuries. The member stressed the importance of integrity tests of all welds on “mission critical” equipment.

**Agenda Item: Regulatory Update**

- Paul Breaux, IADC reminded the committee on a new initiative to provide land based regulatory updates to the group during meetings. The document will be updated every six months as new and existing regulations are proposed, open for comment, closed for comment or are expired.

  - The document was reviewed with the committee and since there were no questions about the document, Anthony called for a motion to consider the Swamper Knowledge and Skills Assessment document complete, move to publish on IADC website for members to use and continue with the creation of the Pole Truck Operator Knowledge and Skills Assessment document. Meredith Boyd – Motioned. John Owens – Seconded. Aye – 31, Nay – 0
  - The committee was informed that the task group has begun work on the Pole Truck Operator Knowledge and Skills Assessment document and that the document should be ready for vote by the next committee meeting.
  - One member asked the task group to consider adding "Forklift Operator" to the list of competency documents to be created. The task group agreed to add the job title to the list, but will continue with the previously agreed hierarchy of positions that are used during a rig move.
