MAINTENANCE COMMITTEE MEETING MINUTES

Transocean Training Center 08 July 2009



Call to Order / Introductions

The acting Chairman, Mr. Frank Breland, recognized Transocean for hosting the meeting and welcomed all members and thanked them for their attendance. A building security and comfort briefing was given by Mr. Frank Edwards (Transocean Training Center). A short personal introduction was then given by each attendee followed by a review of the agenda by Mr. Breland.

IADC Antitrust Policy and Guidelines - The IADC Antitrust Policy and Guidelines were verbally reviewed with the attendees.

Review of action items

Action Item #1 review: Mike Killalea (IADC) reviewed the Advanced Rig Technology Committee mission, including a description of their subcommittees (Reliability, Software Technology; and Future Technology). Mike provided an overview of the survey procedure that will be used for researching the topdrive issues; and how the online system will be used by showing the group visuals from the actual online system. He stated that the ART committee is looking to have the survey completed and instituted by the end of this month (July). He further indicated that the generic results for the industry should be published and available at regular intervals once the system is up and running.

Action Item #2 review: John P pointed out that his research indicated that the EPA does not provide an Environmentally Friendly Lubricants (EFLs) list due the time and resources needed for its upkeep. Additionally, he reported that the USN does not have a specific site either, but that there is a website that is supported by the Joint Services, the Defense Logistics Agency, and the U.S. Coast Guard regarding pollution prevention and includes recommendations as to the use of EFLs.
